

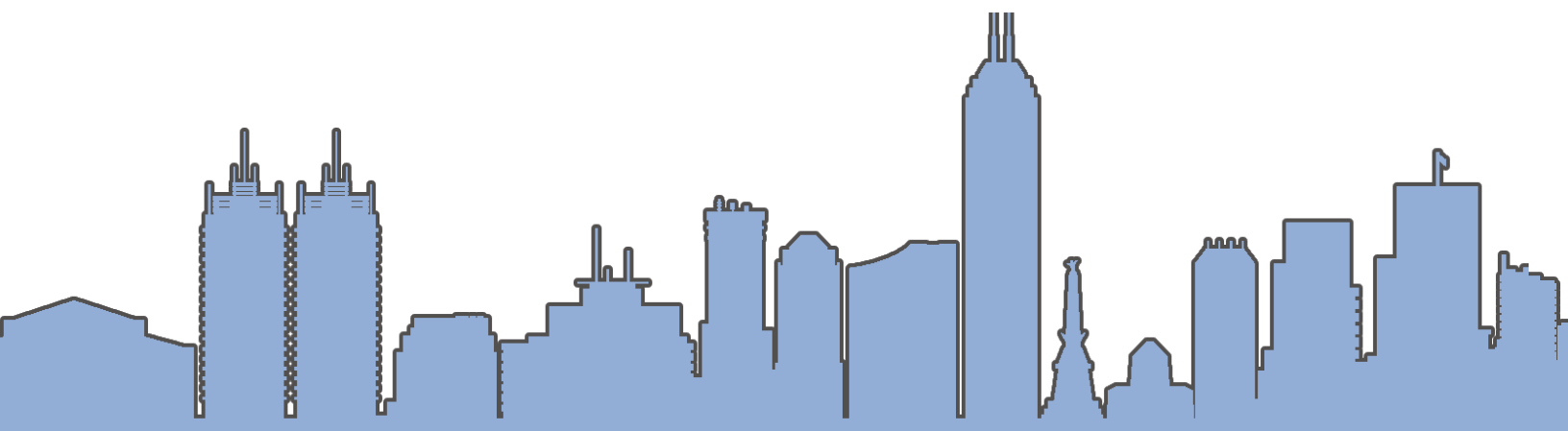

Damon Carson is the founder and President of repurposedMATERIALS--a unique materials management company based out of CO, with a national network. This company is Carson's second foray into America's waste stream; previously, he and a partner founded a garbage hauling company in two Colorado ski resorts, Vail and Breckenridge, which he sold to Waste Management. Moving away from traditional waste management, repurposedMATERIALS has assisted countless organizations in landfill diversion via repurposing, including the US Army, Denver Broncos, Nestle, Purina, Paramount Pictures, and more. Carson has been a keynote speaker at multiple conferences across the country.
